

APPENDIX A - WEBSITE PRIVACY POLICY

Augusta Resource Corporation ("Augusta") is committed to protecting and respecting your privacy. This policy sets out the basis on which any personal information Augusta collects from you or that you provide to us will be processed by us through our website. Please read the following carefully to understand our practices regarding your personal information. This privacy complies with all applicable privacy legislation.

Definitions

“Contact Information” is information that enables an individual to be contacted at a place of business, including their name, position, business telephone number, business address, business e-mail or business fax number.

“Personal Information” is information about an identifiable individual, but does not include contact information or work product information.

“Work Product Information” is information related to an individual’s employment or business which is prepared or collected by the individual or group of individuals as part of their employment or business responsibilities.

- If you use our website, Augusta may obtain information about your general internet usage by using a cookie file stored on the hard drive of your computer to improve the

personalized service of our website. You may refuse to accept these cookies, however if you select this setting, it may affect your usage of the website.

Uses of Your Personal Information

Augusta may use personal information held about you in the following ways:

- To notify you about changes to our service.

Disclosure of Information

Augusta may disclose your personal information to any of its subsidiary companies as defined in the Canadian Business Corporations Act.
